

NOW IS THE TIME TO SIGN UP FOR ELECTRONIC TAX FORMS!



Advantages of Electronic Delivery

- Eliminates the chance that tax forms will get lost, stolen, misdirected, or delayed during mail delivery
- Gives access to tax forms earlier than the traditional site pickup process
- Provides access to tax forms from anywhere at any time
- Saves district resources due to reduced printing and delivery costs

Employees who do not sign up to receive their tax forms electronically will only have the option to have them delivered to their school site. The default option is listed as school site. **Therefore, if you do not choose to log in to make a selection, your tax forms will be delivered to your school site.**

Signing Up for Electronic Delivery

Log in to your Employee Portal: <https://ok.wengage.com/BrokenArrow/accounting/employeeportal>

Click on **IRS e-Consent** tab. Check the box if you would like to receive the forms electronically and then click "I Accept".

W2 e-Consent Statement

I understand that Broken Arrow Public Schools (the District) is obligated to issue to me, annually, a W-2 statement. I also understand that the District must send that statement to me by U.S. mail to my last known permanent address (or hand deliver it to me) unless I affirmatively consent to the delivery of that form via the employee portal. I understand that my consent will remain active until I choose to withdraw consent. Further, I understand that I may choose to withdraw my consent at any time, however, I understand that withdrawal will not impact any previously issued W-2 statements. I also acknowledge that at any time I may request a paper copy of my W-2 which will constitute my withdrawal of consent. Finally, I understand that my termination of employment will also constitute my withdrawal of consent and that it is my responsibility to keep my contact information up to date with the District. I hereby affirmatively consent to the issuance of the form by the District to me via the employee portal.

1095-C e-Consent Statement

I understand that Broken Arrow Public Schools (the District) is obligated to issue to me, annually, IRS form 1095-C known as the Employer Provided Health Insurance Offer and Coverage form. I also understand that the District must send that form to me by U.S. mail to my last known permanent address (or hand deliver it to me) unless I affirmatively consent to the delivery of that form via the employee portal. I hereby affirmatively consent to the issuance of the form by the District to me via the employee portal.

To retrieve forms, select the tax year from the drop-down. Click on the specific form to print. *Note: An email will be sent to all employees when the 2021 forms are available.*

Please Be Advised of the Following:

- Electronic tax forms will be a Portable Document Format (PDF) that requires Adobe Acrobat Reader. If you do not already have Adobe Acrobat installed, a free copy may be downloaded at <https://get.adobe.com/reader/>.
- **Employees who have elected to receive their tax forms by electronic delivery will continue to receive them electronically each year unless the election is changed by notifying payroll.** At any time throughout the year, employees may re-print a duplicate copy of their tax forms from Broken Arrow Public Schools. That request will not change the election to receive future tax forms via electronic delivery.
- Electronic delivery of tax forms is terminated after a person is no longer a full-time or part-time employee of Broken Arrow Public Schools. All provisional and former employees will receive paper tax forms mailed to their home address.
