INSTRUCTIONS: This sealed bid must be submitted to the Purchasing Department, Broken Arrow Public Schools, 701 South Main Street, Broken Arrow, Oklahoma, 74012, no later than 1:00 PM, May 13, 2024. The Broken Arrow Board of Education cannot be responsible for lateness of bids due to mail delays. Bids submitted by facsimile machines or by e-mail are not acceptable.

Sealed bids must be figured F.O.B. Destination, Broken Arrow, OK. Broken Arrow Public Schools is Tax Exempt; therefore, state and federal taxes should not be included in bid price. This bid form or a reproduction showing the identical information must be used to submit the bid. Please bid in accordance with the bid specifications. Bidders may bid on any or all parts of the bid. The "Non-Collusion Statement" and the "Business Relationship Affidavit" must be dated, signed, and notarized according to Oklahoma State Law. No bidder may withdraw his bid for a period of thirty (30) days after the bid opening.

ANY VARIANCES ON THE CHASSIS, THE BODY OR ON ANY OTHER ITEMS LISTED IN THE BID SPECIFICATION (SEE ATTACHMENTS) MUST BE NOTED ON THE SPECIFICATION PAGES AND RETURNED WITH THE PROPOSAL. Complete literature and specifications must be submitted with the bid. No formal showing of the bus units will be conducted unless requested by school officials.

Delivery time of the buses must be stated on the bid. If the buses cannot be delivered to Broken Arrow Public Schools on or before the indicated delivery date, the successful bidder must inform Broken Arrow Public Schools in writing when that delivery date will occur.

Provided the buses pass district inspection, payment will be processed as soon as possible after delivery of the buses.

BID AWARD: The number of buses and sizes awarded will be determined by the price and district needs. The objective is to purchase as many buses as possible in the sizes necessary to meet the transportation needs of the district. Therefore, each bus may be considered and awarded separately. There could be more than one successful bidder.

#### BUSES SHALL NOT BE ORDERED UNTIL SUCCESSFUL BIDDER IS IN RECEIPT OF A VALID PURCHASE ORDER.

The right is reserved by the Broken Arrow Board of Education to reject any or all bids or parts of bids, and to award the bid in the best interest of the school district after comparing specifications, performance, service, quality, price, availability of firm, and delivery dates. All of these factors will be considered and evaluated by school officials before making a decision. All bids are public record and are available during regular office hours. The Broken Arrow Board of Education reserves the right to waive informalities or minor irregularities in the bid.

Bids will be publicly opened and read aloud at the above mentioned office following closing time stated above. Bids received more than ninety six (96) hours, excluding Saturdays, Sundays, and holidays, before the time set for opening bids, as well as bids received after the time set for opening bids, will not be considered and will be returned unopened.
